How long we will keep your personal data for	<p>We will keep your full name, date of birth and qualification obtained as a record of qualification for 20 years. All other personal data will be retained for 3 years.</p> <p>For endorsement purposes, we will normally keep personal data for 2 years, after this time period it will be securely deleted.</p> <p>For vetting purposes, we will normally retain basic details of who you are and the disclosure outcome indefinitely. In limited cases, we may retain a copy of your DBS certificate during the course of any investigation or enquiry. In accordance with DBS requirements we are required to keep basic information about you for a period of up to 7 years, this includes:</p> <ul style="list-style-type: none"> • your name • your date of birth • your post code • your DBS application form reference number • the disclosure type • the date your application was completed • your DBS Certificate number
